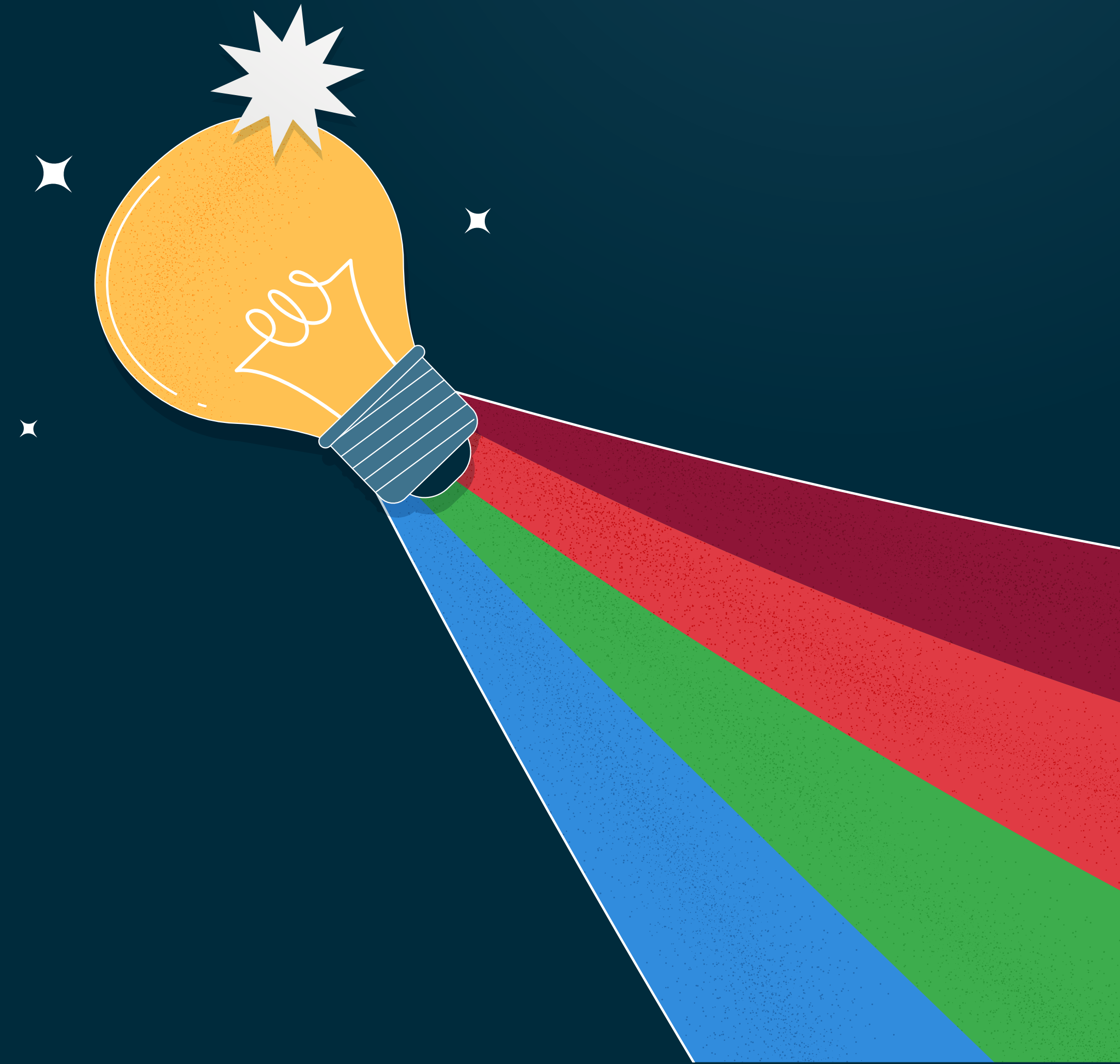

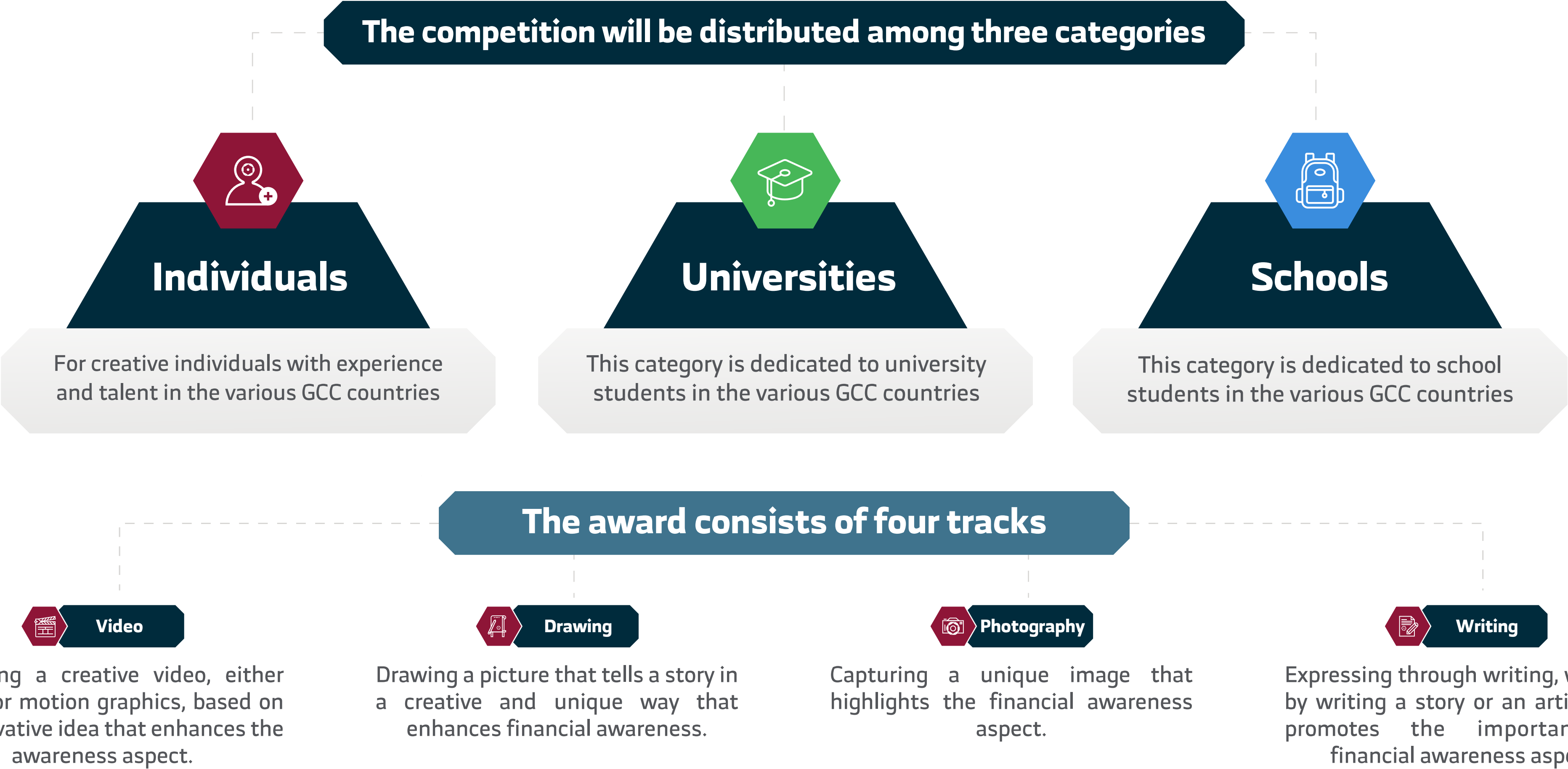
About the "Gulf Smart Investor Award"

Work Quality: Includes factors such as lighting, color consistency, acting, and text quality.

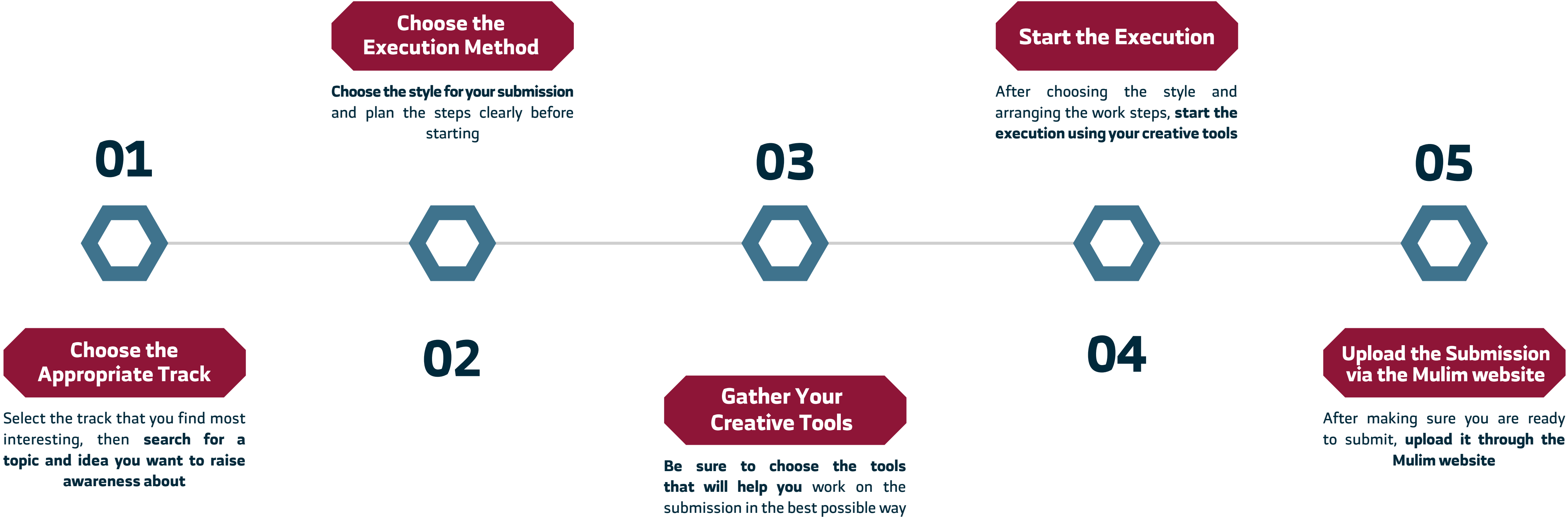

Submission Samples

Reasons for Acceptance

- The submission has an awareness aspect
- Good production quality, filming, and effects
- The use of audio effects with owned rights

Reasons for Rejection

- Unclear idea
- Lack of awareness or investment aspect
- Copyrights of the music used

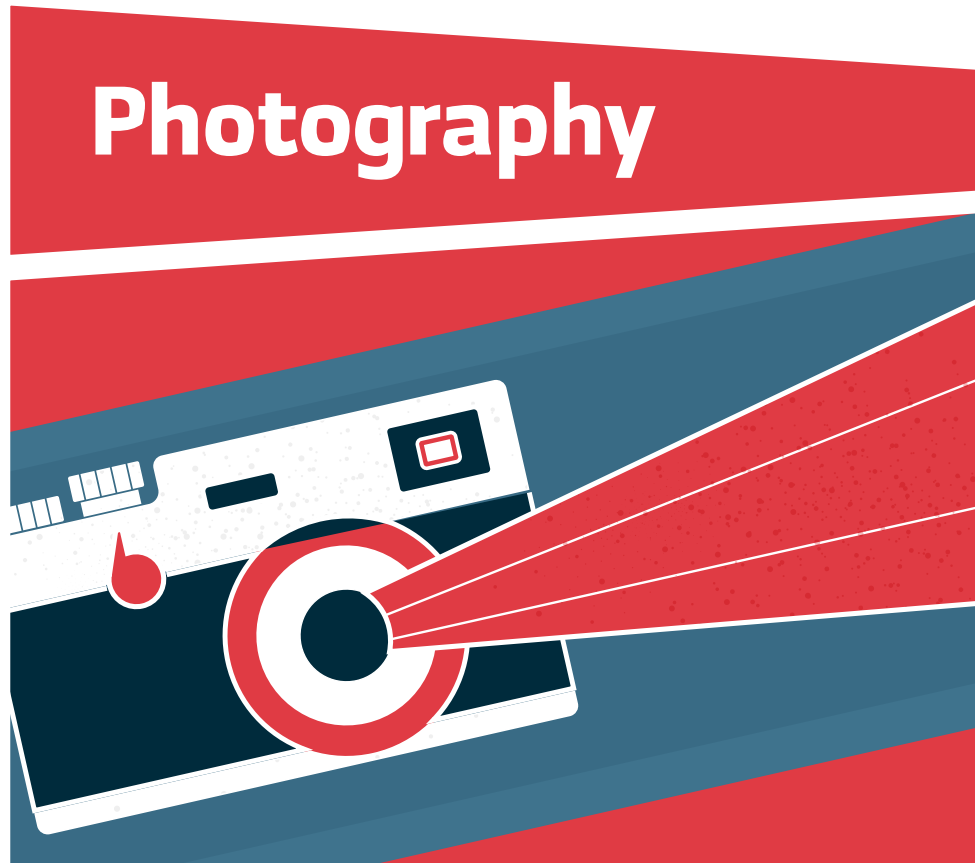
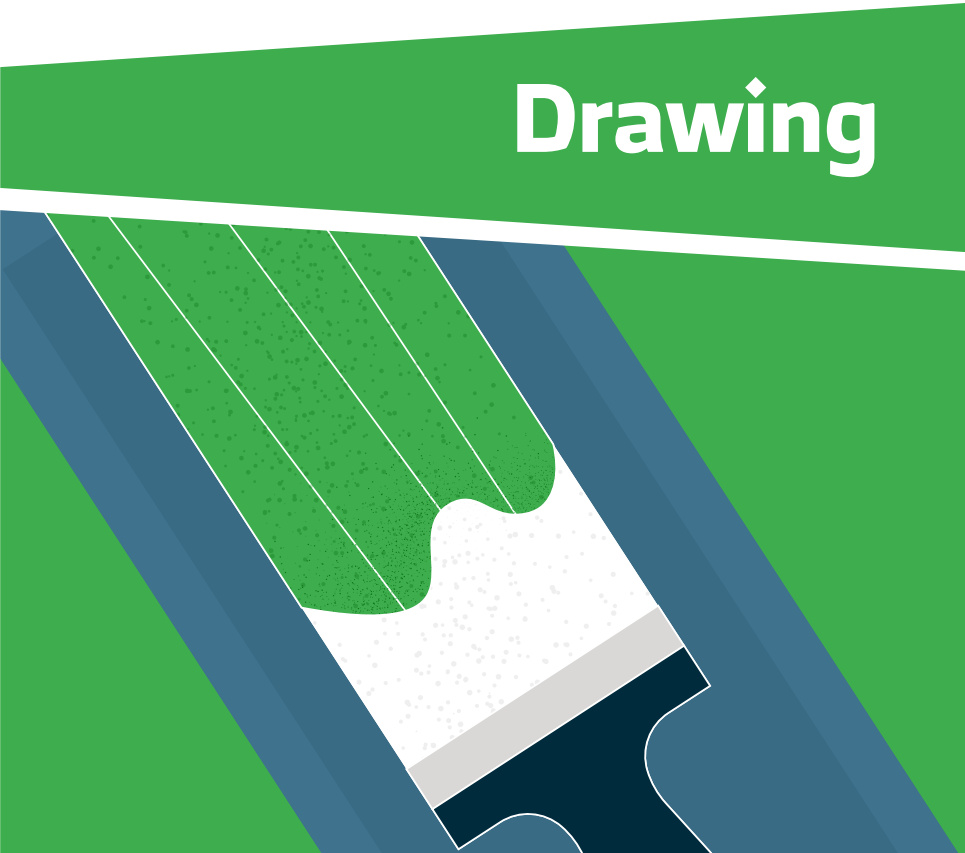
Submission Samples

Reasons for Acceptance

- Quality of the work and tools used
- Idea and creativity, and enhancing the awareness aspect of financial culture

Reasons for Rejection

- The use of ready-made drawings



Submission Samples

Reasons for Acceptance

- Clear idea
- The presence of a financial awareness aspect

Reasons for Rejection

- Unclear idea
- Lack of awareness or investment aspect
- The submission does not meet the criteria for the photography track

Submission Samples

Reasons for Acceptance

- The submission text has a title
- Adherence to the allowed word count
- Good sequence of events in the text

Reasons for Rejection

- No title for the submission text
- Exceeding the allowed word count
- Some spelling errors in the text
- Failure to submit the file in the correct format



Submission Form

Participants in the award can upload their submissions **on the Gulf Smart Investor Award page** on the Mulim website. This is done by filling out a simple form and uploading the submitted material.
